Public in attendance: approximately 15 members of the public present.

1. **President's Remarks**. Councilman Harry Prey suffered the tragic loss of his son. A moment of silence was held for Austin Prey.

Noted the splash pad is out of service, the street paving project has started, refuse containers and planters for the Avenue have been received. Betty Riggs was recognized by the Board of Elections for 50 consecutive years of voting. Kelly Johnson of the Heart of Matamoras was invited to speak. She stated that on October 19th the Heart of Matamoras would be holding a Photo Exhibit/Auction. All entries must be from the 18336-zip code. Proceeds will be put towards future events sponsored by the Heart of Matamoras. She asked Council if they would like copies of the auctioned pieces to display around town buildings. Council was stated that they would.

 - Dimitry Roby 105 Pennsylvania Avenue: Inquired if the existing building located at 111 Pennsylvania Ave was coming down, if so, it will then be new construction and becomes a nonconforming use. Also commented on the liquor permit. Noted he is officially an intervener for the hearing with the PA Liquor Authority about the liquor license request at 111 PA Ave and because of this he needs to know if the building is scheduled to be demolished. Also noted that he could not get an answer from our Building Inspector on this matter.
 - Pete Sigreto 602 Ave N: Read in the paper that the Borough is applying for a grant for sidewalks to the school. He noted that over the years he has observed that the children use 6th Street to get to school and that there will be a need for more trees to be removed on 7th than 6th. He would like Council to take this under consideration.
 - Betty Riggs 700 PA Ave shared upcoming events such as Sunday the 13th of August the Historical Society will have a meeting at 2pm. Sept 9th and 10th there will be an historical exhibit in the Annex and on September 11th Veterans Park will be holding their annual candlelight vigil at 6 pm.

- Mayor: Janet Clark: The Matamoras/Westfall Historical Society will be putting on a display September 9th and 10th. There will be quizzes and prizes.
- General Government Committee: Harry Prey: Shawn Bolles is working on violations ranging from illegal burning, work being performed prior to obtaining permits and chickens running around the town.
- Fire Committee: John Bush Jr/Sean Alessandra: Mr. Bush noted the he gave the Fire Department an insurance check that has been received and the fire truck may need to be brought to Lancaster for repairs, he will keep everyone posted. He spoke about installing a ductless air/heat unit. Hose testing needs to be done on the fire trucks. Tires need inspected on the truck; they may need replacement.
- Public Works: Harry Prey: Read DPW report. Right-a-ways are being cut back. Paving has started. Bob Howard is spearheading the project; he noted that catch basins are outdated. Keep this in mind for the next paving project. Brush pickup is ongoing.
- Facilities Committee: John Bush Jr.: Stated the Firehouse Hall emergency door is broken. He is
 obtaining quotes.
- Finance Committee: Dave Clark: Noted he initiated the refund for the Kelly and Steve Weber. They paid a total of \$2527.47 in taxes, of which \$1,693.78 is due from the Borough and the remaining balance is due from the County. At next month's council meeting all Council members will their budget worksheets and will have two weeks to complete them.
- Planning Mark Madsen: August 22 Peter Wulfhorst will be presenting a PowerPoint presentation to on responsibilities of the Planning Committee. Mr. Madsen invited Council and the public to attend.
