Public in attendance: approximately 15 members of the public present.

1. President's Remarks.

We did not receive any Airport Park Basketball Court sealed bids. This will be put out to bid again next month.

Special thanks to Jeff's Garden Shop for their generous donation of flowers for the planters along Pennsylvania Ave. There have been 9 planters, 6 garbage receptacles and 12 trees planted along the Avenue this year.

The 9/11 service at Veterans Park was well attended. Thanks to Hope Church, members of the Veterans Committee, Mayor Clark, Broome Street Band, the Matamoras Fire Department and all who attended and helped. Noted there was new lighting installed in the Gassman Pavilion and there will soon be walking paths around Veterans Park.

Mr. Bill Clark of the Matamoras/Westfall Historical Society put on a very beautiful and informative display of local history in the Borough Annex over the weekend. Thanks for his dedication and hard work to make this happen.

 - Dimitry Roby 105 Pennsylvania Avenue: Had a complaint about not being able to review the existing plans for 111 Pennsylvania Ave. There was discussion on processes and rights. Mr. Ohliger noted that rights are subjected to rules that must be followed. Mr. Roby noted the PA Liquor Authority is holding a hearing regarding this regarding this establishment/license and wondered why the town was not an intervener. Talked about the existing building being demolished and stated that when the building is torn down, they lose the rights for their existing nonconforming uses.

5. Reports:

- Mayor: Janet Clark: The Matamoras/Westfall Historical Society put on a display and all who
 were involved should be very proud. The 9/11 Ceremony was very special and poignant. It was
 very well done and she thanked everyone involved, in particular Pastor Gilpin of Hope Church
 and Jane Drake.
- General Government Committee: Harry Prey: Shawn Bolles is working on violations including illegal vehicles and complaints regarding high grass.
- Fire Committee: John Bush Jr/Sean Alessandra: Mr. Alessandra noted there are items that the Fire Department needs to purchase, however they have already spent their budget. He asked Council to approve carryover funds be made available in the amount of \$3,979. Motion to disburse funds for the purchase of needed items. M: Losee/Prey. All in favor.
- Public Works: Harry Prey: Read DPW report. Brush pickup is ongoing and noted there is a lot of brush this year. Stated that once the leaf machine is put into operation, brush pickup will be suspended. The paving project has been completed, thanked Bob Howard for his help in overseeing the project. Asked the public to please respond to PCLP if they contact them regarding the gas lines. President Kudrich noted that the bridge revitalization project will begin next March and 2 lanes will remain open for travel. The open grate deck will be replaced with a hard surface.
- · Facilities Committee: John Bush Jr.: Not present. Report will be filed.
- Finance Committee: Dave Clark: Budget worksheets will be given to Council tonight, requested each member complete the highlighted areas. Budgets must be returned no later than September 30th; October 4th is the 1st budget workshop. Noted Wade reimbursement for the month is \$3,993. Mr. Clark talked about the application the Fire Department would like to submit to PennDOT for a Solicitation Permit to fundraise.
- Planning Mark Madsen: There will be a meeting next Tuesday at 7pm and there is a Conditional Use application that will be considered.
- Recreation Advisory Board: Jon Maney/Lisa Salvato: Pam Conklin noted the Park after Dark event was a success. There were over 200 attendees. Their September 5th meeting has been rescheduled for September 20th.
- Eastern Pike Regional Police: Corporal Adams read the report. Noted two new Officers have
 joined the Department. Reminded everyone that school is back in session and asked that every
 please drive safely. Encouraged all to visit pike.crimewatchpa.com
- Asst Fire Chief: Todd Kowinski: Read report. There are 9 new members, 7 of which are Jr. Members. He spoke positively about the Jr Fire Department members and the program. Discussed Fall Festival Special Events application.
- Emergency Management: Tom Olver: Report on file, read by Eric Kudrich. AM radio station remains operating and reliable 24/7/365. EMA web page has been updated and secured. Reminder that we are in the peak of the hurricane season. Be prepared. For more information contact Tom in the EMA office at any time or at ema@matamorasborough.com.
- Police Commission: Dave Clark and Sean Alessandra: Reviewed police pension, discussed creating a Police Impound Lot as a revenue stream. Not sure of the feasibility, but they are looking outside the box for ways to generate revenue. Still working on getting parts for equipment that was impacted by the lighting strike. There will be a special meeting tomorrow night, Executive Session, to gather comments from other Commission Members regarding the budget. Council will receive a copy of the Police budget by Thursday morning. Joint Budget Meeting is September 18, 2023 in the Borough Annex at 7pm. The Department is fully staffed for the 1st time in years and there is a candidate that will be starting the academy in January.
