Instructions:

In order to be fully registered and have a "Pooch Pass" you will need to provide the following

- A municipal dog license certificate- provide us a copy as we need to keep it on file.
(there is a copy machine at the Borough Office at 10 Avenue I, Suite 1, Matamoras, PA)
- A filled out and signed registration form (page 2)
- A filled out and signed waver form (page 3)
- Take the above three items to the Borough Office or mail with your payment to, 10 Avenue I, Suite 1, Matamoras 18336 and pay your fee and pick up your Pooch Pass.

Welcome to the Park!

Basic Requirements:

In order for your dog to be registered and use the dog park the following requirements must be met:

- Dog(s) have never bitten, attacked another human or dog.
- Dog(s) do not act in a violent or threatening way.
- Dog(s) licensed within their home municipality.
- Dog(s) have current vaccinations and is in good health.

Registration Fee:

- Residents of the Borough of Matamoras - **FREE**
- Non-Residents-\$15.00 per family

Registration fees go to cover the costs associated with operating the park which includes but is not limited to:

- Insurance
- Supplies-trash, bags, signs, tags, etc.
- Maintenance-lawn cutting, filling holes, etc.

Matamoras Airport Park Dog Park Membership/User Waiver and Consent Form

The Borough of Matamoras require all users to consent and agree to the terms of personal responsibility while using the dog park. While every attempt is made to operate an enjoyable and safe park, each user is solely responsible for the actions of their dog(s) as if this were a public area, no different than sidewalk, neighbor's yard, parking lot, or even your own home.

- I confirm that my dog(s) have **never bitten** or otherwise injured a human being or another dog and or have not been deemed dangerous by any municipality.

- I confirm that should my dog(s) ever develop and/or exhibit any behavior in which he/she poses as threat to other people or other dogs, that I will **immediately discontinue** bringing that dog to the dog park.

- I agree that I am fully responsible for all the actions of my dog(s) and that, to the fullest extent permitted by law, that I will defend, indemnify, and hold harmless The Matamoras Borough and its officers against all claims arising out of or relating (directly or indirectly) to the actions of my dog and that should my dog cause any harm to another person or dog that I am fully liable for those actions.

- Should my dog be involved in any accident with another person or dog, I agree to hold harmless The Matamoras Borough and its officers and the liability (if any) rest solely with the owner of the involved dogs.

- I agree that the dog park is run by the community and agree to all the risks inherent in its intended use and agree to indemnify and hold harmless The Borough of Matamoras and its officers against any and all claims, including but not limited to: trips and falls, dog on person impacts, dog on dog impacts, scratches, bruises, etc.
