Public Comment:

Dimitry Roby 105 PA Ave: Noticed there wasn't a public comment on the agenda at the end of the meeting. He would like a comment session at the end of tonight's meeting so he could discuss the industrial zone and the Patel project.

Mr. McIntyre stated that the agenda is clear, if there is any comment to be made then now would be the time to speak. Mr. Madsen differed with Mr. Roby's stance on a second public comment because this commission is an advisory board and the Borough Council has the final say in decisions the Planning Commission proposes to the Council.

Mr. Roby discussed Patel legal issues and then read the smoke shop ordinance to the Commission. He expressed concerns about the impact the Patel business has on neighboring residential structures. Has concerns about the existing building and the demolition of the building. Mr. Roby continued there was a need to discuss the industrial zone and stated he was willing to talk to any of the members at any time to share his concerns. Lastly, Mr. Roby expressed his belief that when an application is presented the applicant or lawyer should be present to discuss their proposed project.
