President's Remarks:

Welcomed Jeffery Olsommer and Robin Skibber, candidates for the State House seat in the 139th District; both candidates gave a brief statement of who they were and why they were running and seeking support. They noted they would be available after the meeting for any questions from the audience.

President Kudich noted that the Easter Events were well attended.

President Kudrich read a proclamation dedicated to Jane Drake and designated April 13, 2024 Jane M. Drake Day. This day coincides with the opening of the park.

Public Comment (When recognized by the president, per Borough Code, state your name and address for the minutes)

Dimitry Roby 105 Pennsylvania noted upcoming legal dates of interest; stated he wrote President Kudrich a letter 5 weeks ago and followed up with a second letter requesting to be put on the agenda. He stated his tax card was outdated and he went to Pike County to have it updated. Claims his building has been nothing but residential, 3 units, since the mid-70's. This would have been 10-15 years prior to zoning enforcement. He stated Pike County made the change and then a borough employee opposed the change. He stated that only the council could make such a decision, not an employee. He then handed all members of the Council a letter he had written. President Kudrich responded to Mr. Roby noting that he looked into this issue. Discussion ensued. President Kudrich stated that he was not being treated any differently than any other resident would be treated. President Kudrich said he would continue to look into his claim.
