

## Borough Council Organization Meeting January 3, 2022 7:30 pm

Mayor Clark administered the Oath of Office to Councilmen John Bush Jr. and Sean Alessandra.

Jonathan Maney and Harry Prey had their Oath of Office officiated at an earlier time.

Moment of silence was held for former Councilman of 8 years and Police Commission Member Kevin Rose and for George Featherman a former Recreation Board Member. Both were dedicated to the community and will be missed.

### **13. Unfinished Business:**

a) On the Road Retail Sales M: Clark/Prey. Discussion ensued.

Motion to approve the land development application with the following conditions:

1. All deliveries will be on premise, no on street deliveries.

- 2. The square footage of the tobacco sales and storage area shall not increase.
- 3. Applicant will allow photographs and measurements to be taken of current tobacco sales and storage area by the Code Enforcement Officer to establish the baseline use to ensure no expansion.
- 4. Applicant agrees to provide financial surety requirements by PennDOT relative to the easement application.

- c) Face Amount Tax Request from Jane Drake, now former Tax collector, for a resident residing at 500 Ave N who qualifies for Veteran Tax-Exempt status. **M: Clark /Prey. All in favor.**
- d) Motion to advertise all monthly meetings along with 2023 budget workshop meetings on October 5<sup>th</sup>, Oct 12<sup>th</sup> and Oct 26<sup>th</sup> at 7:00 p.m. and an additional workshop meeting on Nov 2<sup>nd</sup> if needed. **M: Losee/Bush Jr. All in favor.**
- e) Motion to hire part-time DPW employee for emergency snow removal.

President Kudrich expressed concern that we are lacking a second driver. He has received estimates from Morgan Contractors for labor, no equipment, to assist from 7 a.m. to 3 p.m at a rate of \$40 per hour. Overtime rates after 3:30 pm would be \$60 per hour. May Brothers using their truck and equipment quoted a rate of \$140 per hour, using DPW equipment \$65 per hour. Discussion ensued. This is a fallback plan. Approve both contractors and allow the head of DPW approve who to hire. Mr. Ohliger suggested that only previously announced and approved drivers should be considered.

Motion to authorize the head of DPW to utilize the services of either Morgan Contactors or May Brothers for emergency snow removal conditioned upon previously announced and approved list of drivers at the rate set forth in the quotes provided. **M: Losee/Clark. All in favor.** 

- f) Motion to approve installation of DPW heater. **M: Maney/Losee. All in favor.**
- g) Motion to approve installation of Fire House heater. M: Maney/Losee. All in favor.
- 13. Public Comment: None. Mr. Losee is glad to see younger, new faces & it looks like we have a good group. Also noted that nomination by council, appointments, do not require seconds, they are not motions. President Kudrich presented council with their assignments and emphasized that everyone brings unique skill sets to the community and he tried to match up assignments with their ablilites. Mr. Prey noted the recent passing of Ida Haring, 104 yrs. old. Please keep her family in your prayers. President Kudrich further noted that the borough hall is named after her husband.
